## TERMS & CONDITIONS

KidZania Singapore is solely operated by Rakan Riang Pte Ltd ("RRPL"), the authorized licensee of KidZania, SAPI de CV and a joint venture company between Themed Attractions and Resorts Sdn Bhd (860668-B) and Boustead Curve Sdn Bhd (103320-B), of Malaysia.

### MEMBERSHIP POLICIES

- Corporate Annual Pass (CAP) shall be valid for a period of 12 months from the Start Date of Membership ("Validity Period"), up to and including the "valid until" date which is printed on the CAP card when issued;
- CAP is available for admission of CAP holder's staff only and such staff must be an adult (i.e. 18 years old and above).
- No cards will be issued if the company opts in for the corporate letter scheme.
- The original CAP card or corporate letter, and staff employment pass/card must be presented to enjoy the CAP membership benefits, including admission to KidZania Singapore. (Note: Employee must present staff identification with photo or any other identification pass as RRPL may require at the entry of KidZania Singapore.)
- Each CAP card or corporate letter allows 1 staff and up to 3 accompanying guests complimentary day admission into KidZania Singapore. ### ADMISSION POLICIES

- An adult (aged 18 and above) must be present for the admission of any child regardless of age into KidZania Singapore.
- All Kids below the age of 8 years old must be accompanied by Adults at all times during the entire duration of the visit. For proper care and attention while at KidZania Singapore, it is recommended that each Adult supervises no more than 5 Kids.
